I'm Ann Leonard, owned by a white Fox Trotter "Saturday", who takes me on rides in the Gila National Forest surrounding my home in Rancho Grande Estates near Reserve, New Mexico.

For the past several years our "Hills of Home" have been *infested* by an impure strain of an introduced predator, the Mexican wolf. Wolf packs in both Arizona and New Mexico have killed hundreds of cows and their calves, ranch and home owners' cats and dogs, as well as a few horses.

Wolf Reintroduction groups don't care---they live in cities and make no effort to experience how *their* wolves are devastating our rural counties. Their motto is: "Don't confuse me with facts---my mind is made up!!!"

Well, **facts** are summed up in a brilliant 30 page report "**When Do Wolves Become Dangerous to Humans**" by Valerius Geist, Professor Emeritus of Environmental Science of the University of Calgary, Alberta, Canada.
